To continue modestly expand funding for workforce development to continue the low-income nontraditional student workforce development started with ARPA money, this investment should be built into the City budget. Continue and expand funding for mentoring to connect students with Black professionals. An additional \$2.5M in on-going funding is needed for workforce development. In FY23, \$6.1M in future ARPA workforce programs funding will be available through upcoming solicitation(s). EDD has an agreement with the Greater Austin Economic Development Corporation / Opportunity Austin to assist in closing the performance achievement gap at the high school level among the most at-risk students. EDD's FY23 budget also includes \$3.1M for development and administration of workforce development contracts for workforce development programming matching employers' skill needs and successfully preparing economically disadvantaged residents for family-sustaining careers.
